INFORMATION ON THE PROCESSING OF PERSONAL DATA OF EVENT PARTICIPANTS

In accordance with the information obligation under Article 13(1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) [OJ EU L 2016.119.1 of 4 May 2016], hereinafter referred to as GDPR, we inform you that:

- The controller of your personal data is the AGH University of Science and Technology in Kraków (Academic Computer Centre CYFRONET AGH), Al. Mickiewicza 30, 30-059 Kraków, hereinafter referred to as the Controller;

- 3. Your personal data will be processed for the purpose of registering for the scientific event, communicating with participants regarding the organization of the event, documenting its course, and securing data in case of potential claims and to use the newsletter service (in case you agree to receive the newsletter);
- 4. Your personal data will be processed:
 - a. under Article 6(1)(e) of the GDPR in connection with the Act of 20 July 2018 Law on Higher Education and Science (Journal of Laws of 2024, item 1571, as amended) [ustawa z dnia 20 lipca 2018 r. Prawo o szkolnictwie wyższym i nauce; t.j. Dz. U. z 2024 r. poz. 1571, z późn. zm.] and the University's statutory mission, which includes conducting scientific activities, disseminating and enhancing scientific achievements, participating in social development, shaping civic attitudes, and fostering an innovation-based economy; b. under Article 6(1)(b) of the GDPR, i.e., processing is necessary for the conclusion and performance of an agreement, whose subject is participation in the event; c. under Article 6(1)(c) of the GDPR, i.e., processing is necessary for the Controller to fulfill legal obligations, particularly in terms of financial and accounting documentation and reporting;
 - d. under Article 6(1)(a) of the GDPR and Article 398(1) and (2) of the Act of 12 July 2024 Electronic Communications Law (Journal of Laws 2024, item 1221) [ustawa z dnia 12 lipca 2024r. Prawo komunikacji elektronicznej; Dz.U. 2024, poz. 1221], if you consent to receiving newsletters and marketing communications via email.
- 5. Recipients of your personal data may include:
 - a. entities to whom the Controller is obliged to transfer data under applicable laws;b. entities providing services to the Controller to the extent necessary to achieve the purposes for which your personal data is processed.
- 6. Your personal data may be transferred to state authorities, law enforcement authorities (Police, Prosecutor's Office, Court), or local government authorities in connection with ongoing proceedings;
- 7. Your personal data will be processed only for the period necessary to achieve the purposes of personal data processing, i.e., for the duration of the organization and course of the scientific event, as well as for the period required to satisfy potential claims and the period specified by applicable laws, including provisions regarding the archiving of scientific documentation.

- 8. You have the right to request from the Controller access to your data, rectification, deletion, data portability, restriction of processing, withdrawal of consent, and the right to object to its processing in cases and under the conditions specified in the GDPR. Withdrawal of consent may be made at any time but does not affect the lawfulness of processing based on consent before its withdrawal;
- 9. You have the right to lodge a complaint with the supervisory authority the President of the Personal Data Protection Office [Prezes Urzędu Ochrony Danych Osobowych] (ul. Stawki 2, 00-193 Warsaw) under Article 77 of the GDPR ("Every data subject shall have the right to lodge a complaint with a supervisory authority (...) if the data subject considers that the processing of personal data relating to him or her infringes this Regulation");
- 10. Your personal data will not be subject to automated decision-making, including profiling;
- 11. Providing personal data is voluntary but necessary for the Controller to achieve the purposes for which it was collected. Failure to provide personal data will result in the inability to participate in the event;
- 12. The Controller reserves the right to take photos and record videos during the event, which may be used for documentation purposes (reporting) or promotional purposes in printed and electronic publications as well as on social media profiles of the Controller's organizational units. According to Article 81(2)(2) of the Copyright and Related Rights Act (Journal of Laws 2022, item 2509, as amended) [ustawa o prawie autorskim i prawach pokrewnych; t.j. Dz. U. 2022 poz. 2509, z późn. zm.], the dissemination of an individual's image that is merely a detail of a whole, such as a gathering, landscape, or public event, does not require their consent;
- 13. Taking, publishing, and sharing photos or videos taken by event participants is done solely at their own responsibility and with the awareness of the consequences of distributing the image of others without their consent.
